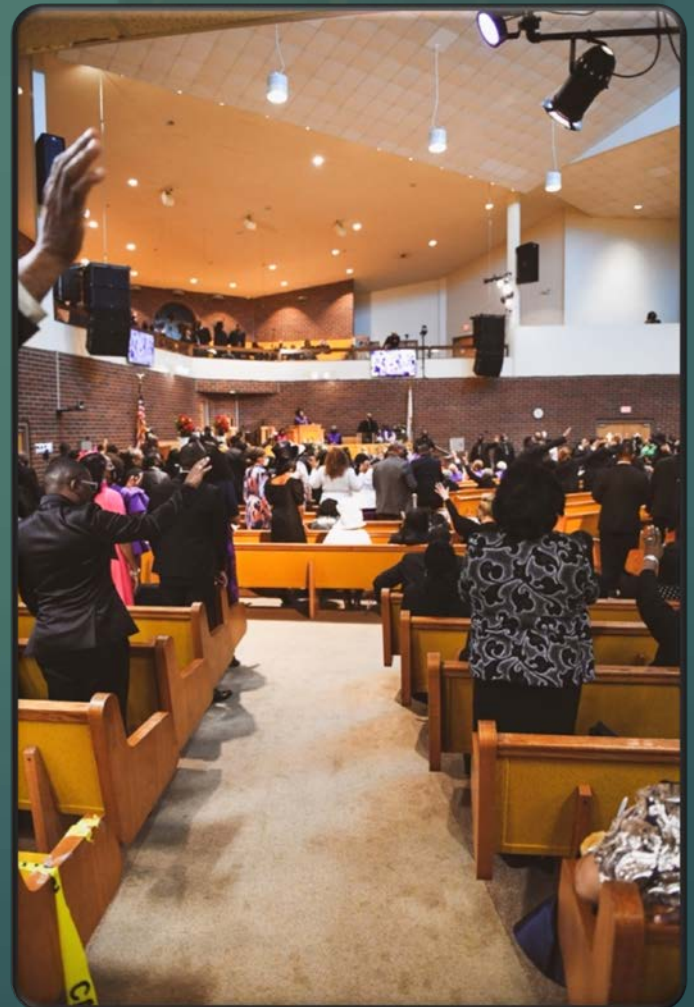




# POST GENERAL ASSEMBLY NOTICE 2021

## HEALTH AND SAFETY PROTOCOL

(July 2021)

If you gather with anyone in a congregational setting, you are encouraged to follow the guidelines distributed by the headquarters staff, which follows the guidelines of the Centers for Disease Control (CDC). Because the risk of being exposed to COVID-19 remains high every time a person is in a gathering or close contact with other people, everyone is encouraged to become fully vaccinated (please consult your physician for more information). If you are not fully vaccinated, you should get tested after each risk of exposure. If you are certain of an exposure to COVID-19, it is necessary for you to contact your physician and quarantine for the recommended period (according to our church and CDC guidelines).

Out of an abundance of caution, the following protocol and recommendations have been prayed about, carefully considered, researched and approved by our Supreme Executive Council:

1. Each Diocese Bishop (or Presiding Prelate) must decide if his or her Sunday Bible School (SBS) Convention and/or State Assembly will be held:
  - a. Virtually
  - b. In accordance with the 2021 Church Reopening Health and Safety Protocol (see below for details)
  - c. In accordance with the 2021 General Assembly Health and Safety Protocol (see below for details) or
  - d. Postponed
2. Until further notice, because **House of God Church SBS Conventions** are primarily for our youth (and guests) and because the United States federal government has yet to approve COVID-19 vaccines for children under the age of twelve (12); a maximum of two (2) days are permitted per Sunday Bible School Convention for in-person gatherings. A SBS Convention may convene for the traditional 3 days if 1, 2 or all 3 days are virtual.
3. Until further notice, because **House of God Church State Assemblies** are traditionally gatherings where guests (with unknown health statuses) from local communities may attend and because the United States federal government has yet to approve COVID-19 vaccines for children under the age of twelve (12); a maximum of two (2) days (per week) are permitted for a State Assembly if unvaccinated people are invited. Officials planning State Assemblies are encouraged to follow the 2021 General Assembly Health and Safety Protocol below (and only invite fully vaccinated people to attend).

4. A State Assembly may convene for more than 2 days in a week if only 2 days are indoor (in-person) services and the remaining days are virtual.
5. If a Sunday Bible School Convention and/or State Assembly is held virtually, assessments and reports are still to be submitted. Unless otherwise notified by Headquarters or the Branch Office, the Bishop and Diocese Officials shall decide how to best carryout the spiritual and logistical responsibilities of each gathering.
6. If a virtual Sunday Bible School Convention or State Assembly is held, utilize every appropriate and reasonable measure to ensure the Gospel of Jesus Christ is shared with the general public in a spirit of excellence. Excellence honors God and inspires people. If you have any questions regarding the steps to effectively conduct a virtual assembly, please contact the Branch Office at your earliest convenience.
7. Once a decision is made regarding the status of your convention or state assembly, please notify the Branch Office or Headquarters by email so that national calendars can be updated, and the Chief Overseer can be notified.
8. If a Bishop or Presiding Prelate (along with diocese officials) decide to reschedule a convention or assembly, please notify the Branch Office by email prior to promotion. All diocese assembly and convention dates should be coordinated with the Branch Office prior to promotion.
9. The Supreme Executive Council has approved an increase for regular weekly in-person gatherings from 2 ½ hours to 3 ½ hours. Additionally, this service time allowance/limitation applies to all gatherings where unvaccinated people are in attendance.
10. There should be no indoor dining/feeding at House of God facilities due to safety concerns related to COVID-19 unless all people in the facility are fully vaccinated and are following the 2021 General Assembly Health and Safety Protocol. If everyone is not fully vaccinated and following the 2021 General Assembly Health and Safety Protocol, food should be distributed outdoors in to-go containers whenever feeding is necessary.



## 2021 CHURCH REOPENING HEALTH AND SAFETY PROTOCOL

In collaboration and guidance with Federal, State and Local Government Officials:

1. Masks shall be mandatory while on the church premises, to be worn by everyone in or outside the building, except when using a microphone
2. Face masks shall be provided (if necessary) to anyone that attends
3. Fellowship and/or gatherings beyond the standard worship service shall not be permitted
4. Microphones must be sanitized between users
5. Buildings must be sanitized before the reopening and between every service
6. Temperature checks must be performed on everyone entering the facility
7. Attendees must submit daily contact tracing forms
8. Indoor attendance shall be limited to 50% of the building capacity. Outdoor attendance is unrestricted
9. Indoor and outdoor gatherings limited to 3 ½ hours total per week\*
10. Attendees should wash their hands, practice 3-6 feet of social distancing\*
11. Hand sanitization spaces must be provided throughout the facility
12. Indoor dining or food distribution at HOGC facilities is prohibited\*

## 2021 VIRTUAL ASSEMBLY/CONVENTION HEALTH AND SAFETY PROTOCOL

In collaboration and guidance with Federal, State and Local Government Officials:

1. Masks shall be mandatory while on the church premises, to be worn by everyone in or outside the building, except when using a microphone
2. Face masks shall be provided (if necessary) to anyone that attends
3. Only 15 people (including program participants, musicians and technical staff) permitted in the sanctuary at a time
4. Microphones must be sanitized between users
5. Buildings must be sanitized before the gathering
6. Temperature checks must be performed on everyone entering the facility
7. Attendees must submit daily contact tracing forms
8. Outdoor virtual attendance is unrestricted\*
9. Indoor and outdoor gatherings limited to 3 ½ hours total per week\*
10. Attendees should wash their hands, practice 3-6 feet of social distancing\*
11. Hand sanitization spaces must be provided throughout the facility
12. Indoor dining or food distribution at HOGC facilities is prohibited\*

3. Face masks shall be provided and recommended to anyone that attends
4. Microphones must be sanitized between users
5. Buildings must be sanitized before the reopening and between every service
6. Temperature checks must be performed on everyone entering the facility
7. Attendees must submit daily contact tracing forms
8. Attendees should wash their hands, practice approximately 3 feet of social distancing
9. Hand sanitization spaces must be provided throughout the facility

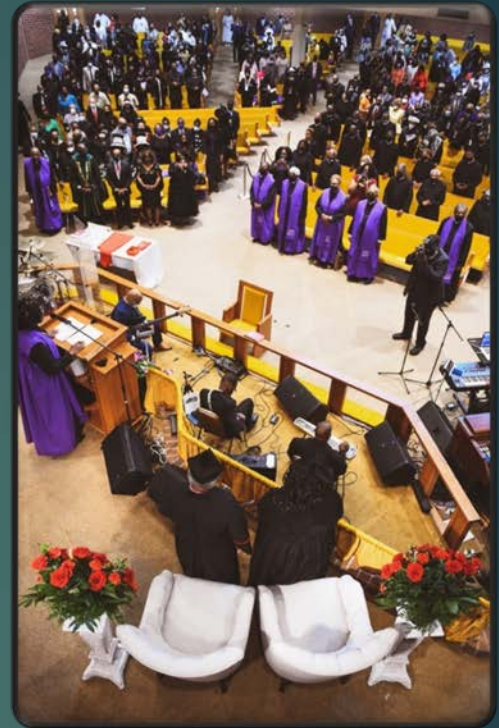

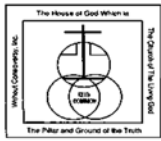
## REMINDERS
